1. Company Overview

Allfor Care Services Limited is a UK-based care provider delivering high-quality domiciliary care (90% of services), as well as supported living (5%) and transportation services (5%). We currently provide over 2,000 hours of domiciliary care per week to vulnerable individuals across the communities we serve.

2. Commitment to Achieving Net Zero

Allfor Care Services Limited is committed to achieving Net Zero greenhouse gas emissions by 2050 in line with the UK Government's target.

We are targeting a 40% reduction in total emissions by 2035 and net zero by 2050.

Milestone Targets:

- 10% reduction by 2026
- 25% reduction by 2030
- 40% reduction by 2035
- Net zero by 2050

6. Carbon Reduction Initiatives

To achieve these targets, Allfor Care Services Limited is implementing the following measures:

A. Transport & Travel

- Phasing out petrol/diesel vehicles and transitioning to electric or hybrid vehicles (50% target by 2030)
- Encouraging public transport, cycling, and carpooling
- Route optimisation for domiciliary care
- Incentives for staff to use low-emission vehicles

B. Energy & Utilities

- Switching to renewable electricity tariffs
- Conducting energy efficiency audits
- Installing smart meters and encouraging energy-saving practices

C. Digitalisation & Remote Working

- Minimising office energy usage through hybrid working
- Expanding use of digital systems (e.g. Carebeans) to reduce travel and paper use

D. Procurement & Waste

- Prioritising low-carbon suppliers
- Reducing waste and single-use plastics
- Implementing recycling and digital-first strategies

E. Staff Awareness & Training

- Sustainability training for all staff
- Appointing a Green Care Champion to lead initiatives

7. Carbon Offsetting

From 2026, Allfor Care Services intends to begin voluntary carbon offsetting for unavoidable emissions, initially focusing on Scope 1 vehicle emissions.

8. Monitoring and Reporting

Progress will be reviewed annually and reported to the Board. Reduction measures will be adapted based on findings and updated emissions data.
